

Trespass Log Book, Milford 1832 – 1840\*

\*The notebook does not have a title; this is my own description of what the book appears to be.

As is customary with transcriptions, I have copied the book using the layout, spellings, grammar and punctuation as appear in the book. There are no page numbers in the book, these have been added to this transcription to enable details to be found more easily. The pages are mostly in pairs. The verso has a list of the trespassers and their fines, the recto lists the money collected and how it has been disposed.
